CONFERENCE PROGRAM

The Conference will take place in Bohinjska Bistrica in the Congress Center Bohinj Eco Hotel from Tuesday, 5th March, beginning at 9 a.m., until Wednesday, 6th March 2024 in the afternoon. Scientific and professional contributions will be presented as 30 minutes invited lectures, short 15 minutes papers and posters. The organiser reserves the right to change the proposed way of presentation.

MAIN TOPICS and OFFICIAL LANGUAGES

The program of the Conference will cover all fields of plant protection. Presentations will be classified according to adequate thematic groups. The official languages on the Conference will be Slovenian and English.

TITLES AND ABSTRACTS OF PAPERS

Deadline for the titles and abstracts of papers is 8th December 2023. They should be written in Slovenian and English language and consist of 300 words at the most. Abstracts should be sent to e-mail address stanislav.trdan@bf.uni-lj.si.

PUBLICATION OF PAPERS

Reviewed and presented scientific and professional papers will be published in the Proceedings of lectures and papers of the 16th Slovenian Conference on Plant Protection with international participation. The complete text of the papers of a volume not exceeding 6 pages, with Slovenian and English abstract shall be submitted by the participants at the Conference or shall be sent to organiser by the 31st March 2024 (detailed instructions for the preparation will be published in the 2nd announcement).

Registrations with abstracts of papers will be accepted until 8th December 2023,

- Papers ready for publication will be submitted at the Conference or until 31st March 2024 at the latest.
- All registrations, abstracts and papers must contain the name(s) and family name(s), institution(s), address(es), phone(s) and e-mail(s) of the first author and the coauthors, the title of the presentation and information about the mode of presentation (oral, poster, participation without presentation).
